The National Park Service has named Plainfield's Downtown Historic District to the National Register of Historic Places. This prestigious honor makes Plainfield's downtown one of only fifteen downtowns in the State of Illinois on the National Register. Each year, the downtown is home to a number of special events including Plainfield Fest, classic car nights, movies and concerts.

Plainfield is also home to the Lake Renwick Heron Rookery, numerous historic landmarks, a wonderful park and trail system, and the DuPage River, which provides numerous outdoor recreational opportunities.

# **Executive Division**

The Office of the Chief plays a pivotal role in overseeing various functions within the department. Under the guidance of the Chief of Police, who leads the Chain of Command, the office ensures that departmental tasks are executed in alignment with established policies, within budgetary constraints, and to the satisfaction of the Village Board of Trustees. This leadership ensures operational efficiency, compliance, and accountability throughout the organization.



The Executive Assistant to the Chief of Police, Jenny Janis, provides administrative support to the Chief of Police and staff. Jenny is responsible for coordinating department presentations, annual reports, strategic plans, compiling the annual budget and maintaining personnel and internal affairs files. Additionally, Jenny coordinates the preparation and execution of all department events including the annual awards ceremony and monthly meetings, and schedules facility maintenance visits. 




### Retirees

# Association for Individual Development (AID)

The Plainfield Police Department contracted with the Association for Individual Development (AID) in July of 2022.

AID is a nonprofit, community based organization that serves over 5,700 individuals with developmental, behavioral and crisis needs across Kane, Kendall, DeKalb, DuPage, Will, McHenry and suburban Cook County communities. AID is a United Way partner agency and is accredited by the Commission on Accreditation of Rehabilitation Facilities (CARF).

Katrina Weber, our dedicated AID Social Worker, provides valuable on-site support two days a week. Additionally, our department benefits from AID's round-the-clock call-out services. Katrina's presence and the accessibility of AID services ensure comprehensive support for our community's needs.



# **Specialty Units**

The Plainfield Police Department assigns officers to two distinct multi-jurisdictional SWAT teams. Two officers from Plainfield are designated to the Joliet Police Department's Special Operations Squad (SOS), while another two officers are part of the Kendall County Special Response Team (SRT). Presently, one of the Plainfield officers within Joliet SOS serves as the Team Leader, overseeing operational planning during responses. Additionally, in 2023, Plainfield expanded its contribution by assigning an officer as a negotiator to Joliet Police Department's Special Operations Squad Negotiation Team.

Both of these teams are capable of responding to high-risk incidents not only within the Village of Plainfield but also across the surrounding areas where the teams operate. Examples of incidents these teams handle include barricaded subjects, armed standoffs, high-risk arrest or search warrants, hostage situations, and dignitary protection. Over the past year, Plainfield has utilized these teams as a tactical asset for special events.

The participation of Plainfield Police Department members in these two teams augments the Village's resources for managing critical incidents that may occur.

# **Specialty Units**

Officers assigned to specialized teams demonstrate versatility by undertaking tactical duties within the police department, even without the full activation of their teams, particularly during notable events such as the Plainfield Fireworks and the Harvest 5K. Additionally, some officers are part of the Illinois Law Enforcement Alarm System (ILEAS), enhancing our department's capabilities and readiness for various scenarios, ensuring the safety and security of our community during such events.

In 2023, the department's contingent of three officers assigned to ILEAS responded to three incidents. They provided support to Romeoville in the search for an offender who shot an officer, assisted Tinley Park during a planned demonstration at a Jason Aldean Concert, and aided Joliet in managing the Mexican Day Parade protest and street takeover.





# **Legal Division**

The Legal Division was under the management of the department's Legal Counsel, Joan Meyers, until her appointment to the Office of Associate Judge of the Twelfth Judicial Circuit in September of 2023. Hired in January of 2024, the division is now overseen by Legal Counsel, William Lite. Apart from representing the department on legal matters, such as FOIA requests, criminal expungements, and labor and employment issues, the Legal Counsel leads the Village's local prosecutions, assisted by Associate Prosecutor Debra Abbott. Legal Assistant Michelle Mendoza is responsible for managing the Legal Division's administrative tasks.

The Village conducts prosecutions at the Village's Branch Court, situated at the Plainfield Law Enforcement Center, and at the Will County Courthouse. In 2023, Ms. Meyers and Ms. Abbott handled over 675 cases monthly on behalf of the Village. The cases heard at the Village's Branch Court range from petty traffic offenses to violations of the Village's Code of Ordinances, encompassing charges for disorderly conduct, battery, assault, possession of cannabis under ten grams, possession of drug paraphernalia, underage consumption, criminal trespass to property, criminal damage to property, and damage to Village property. Misdemeanor traffic offenses, including DUI, driving while license suspended, driving while license revoked, aggravated speeding, and reckless driving, are prosecuted at the Will County Courthouse.

With support from the Legal Assistant, the Legal Division also handles the preparation of court files, coordinates Officers' schedules for court appearances, notifies witnesses for court proceedings, processes subpoenas and other requests for information, and manages citations, complaints, and bond procedures with the Will and Kendall County Circuit Court Clerk's Offices, among other court-related duties. Additionally, the Legal Division keeps Officers informed of new laws and provides relevant training to assist them in their day-to-day duties.

Furthermore, the Legal Division oversees the Village's Administrative Adjudication hearings, including those related to vehicle impoundment and the Village's Red-Light Camera Automated Enforcement program. In 2023, the Village continued its vehicle impoundment efforts for public safety violations as outlined in the village's impound ordinance. The impound and storage fees collected in the calendar year 2023 amounted to approximately \$28,365, covering various violations of the vehicle code in addition to other offenses.

The Village's Red-Light Camera Automated Enforcement program continues to be part of the Village's traffic safety program. The automated red-light cameras located in the Village of Plainfield have been successful in increasing traffic safety, by reducing red-light running violations and crash incidents. In calendar year 2023, the Village continued the operation of its Red-Light Camera Automated Enforcement program at the intersection of IL Rt 59 and 135th Street. Fines paid as a result of the Red-Light Camera Enforcement program were \$383,706, while expenses for the program were \$101,462.48.





### **Administration Division**

The Administration Division plays a crucial role in advancing the mission of the Plainfield Police Department through its focus on criminal investigations, evidence collection and processing, and provision of police services to schools and youth within the Village of Plainfield's jurisdiction. Personnel within this division are highly trained specialists in their respective roles, offering expertise and services beyond standard patrol duties.

Commander Kevin McQuaid provides policy level guidance and budgetary oversight for the Division. He is assisted by Operations Support Specialist AnnaMarie Flood. AnnaMarie supports all three divisions, but specifically the Administration. Her duties include administrative tasks for the Criminal and Juvenile Investigations Units, grant funding coordination, processing of special event permits and various other administrative functions.

Cheri Pistilli, Accounting Assistant, processes all department invoices and receivables. She also analyzes monthly department accounting reports to maintain expenditure controls and coordinates drug forfeiture funds for reporting requirements.

Under the supervision of Detective Sergeant Ron Mikos, the Criminal Investigations and Property/Evidence Units carry out their duties. Detectives diligently investigate criminal cases, assisting in identifying perpetrators and providing support for prosecutions. Crime Scene Investigators, supervised by Sergeant Amanda Felgenhauer, collect and process physical evidence, which is then submitted to crime labs by Property Custodian Tim Beam for analysis and storage. Beam is responsible for maintaining all evidence, as well as seized and found property, until cases are resolved or rightful owners claim their property.



The Juvenile Investigations Unit delivers police services to students, faculty, and visitors within facilities of Plainfield School District #202 and Oswego School District #308, situated within the Village's boundaries. School Resource Officers (SROs) collaborate closely with school faculty and staff to investigate crimes and uphold a secure school environment. Each SRO possesses extensive training in juvenile law matters. The D.A.R.E. (Drug Abuse Resistance Education) Program offers 5th-grade students lessons aimed at fostering positive decision-making and steering clear of involvement with drugs, alcohol, and violence. A Juvenile Detective is tasked with conducting follow-up investigations concerning runaway juveniles, non-violent offenses involving identified juvenile offenders, and other related incidents.



### **Criminal Investigations Unit**

Detective Sergeant Ron Mikos oversees both the Criminal Investigations Unit and the Property/Evidence Unit. The Criminal Investigations Unit consists of four general detectives responsible for investigating various person and property crimes. Additionally, two detectives within the unit hold specialized roles: one collaborates with the Federal Bureau of Investigations (FBI) at the Regional Computer Forensic Laboratory (RCFL) as a Digital Forensic Investigator, while the other works with the Illinois State Police as a Narcotics Investigator within the Will County Cooperative Police Assistance Team (WCPAT). These detectives, partnering with federal and state agencies, receive portions of seized funds and partial wage reimbursements as part of their assignments.

This Unit plays a crucial role in providing investigative support to the Patrol Division. Detective Sergeant Mikos meticulously screens reported incidents to identify cases needing further follow-up, which could strain the resources of the Patrol Division. Detectives are assigned cases involving multiple interviews, out-of-town follow-ups, crime scene work, surveillance, obtaining search warrants, serving subpoenas, and assisting other law enforcement agencies, among other duties.

# **Evidence Response Team**

(ERT)

In 2023, The Plainfield Police
Department formed an Evidence
Response Team (ERT). The team,
which is lead by Sergeant Amanda
Felgenhauer, is comprised of officers
within the Patrol and Administration
Divisions who serve as Crime Scene
Investigators (CSI). The CSIs receive
advance training and skills in the
identification, collection, and
processing of physical, biological and
digital evidence.



### **Property Custodian**



In 2023, the Plainfield Police Department acquired roughly 1,393 pieces of property tied to crimes or violations. Tim Beam manages the secure storage of all evidence and property held at the department, following strict accreditation policies to safeguard their integrity. This role is crucial in maintaining the chain of custody for evidentiary items essential for criminal cases. Tim meticulously documents any movement of items using the Beast Evidence Maintenance System. Additionally, he oversees inventorying impounded vehicles, supplying court materials, processing crime scenes, managing asset forfeiture/seizures, and handling property disposal.

Tim recently marked his fifth year of dedicated service with the Village.



# Juvenile Investigations Unit

This year, the unit within the Plainfield Police Department previously known as the School Resource Officer Unit is now recognized as the Juvenile Investigations Unit. The unit comprises one Sergeant, five SROs, two D.A.R.E. Officers, and one Juvenile Detective. Its primary responsibility is handling all calls related to the schools within the village. Plainfield School District 202, the 5th largest in Illinois, encompasses eight elementary schools, four middle schools, and three high schools. Additionally, within District 202 are the Administration Building, Bonnie McBeth and Ina Brixey Learning Centers, and the Plainfield Academy. Furthermore, the Village hosts an elementary school and a middle school from Oswego School District 308, the 7th largest in Illinois. Private institutions like Parkland Preparatory Academy, Menta Academy, and St. Mary Immaculate, a Catholic K-8 parish school, bring the total to 22 schools within the Village of Plainfield.

The School Resource Officer (SRO) Program functions as a school-based, community policing initiative with specially trained officers aiming to foster positive relationships among officers, students, staff, and parents. All officers in the Juvenile Investigations Unit hold certification from the Illinois State Training and Standards Board as School Resource Officers. They are self-motivated individuals with several years of police experience and adeptness in engaging with the public and youth, following the SRO triad model of Mentor, Educator, and Law Enforcement Officer.




## Juvenile Investigations Unit

The unit assigns one SRO to each high school, one to Plainfield Academy, a middle school SRO to cover all four middle schools in District 202, and one Juvenile Detective to substitute for an absent SRO or cover other designated schools as required. The Juvenile Detective also responds to Parkland Preparatory Academy and Menta Academy as needed and spends one day a week at Oswego's Middle School, Murphy Jr. High School. When not attending to school-related matters, the Juvenile Detective handles cases involving juvenile offenders. SROs assist school administrations in investigating criminal activities within schools and contribute to maintaining a safe and secure learning environment. They not only address criminal incidents but also deliver various classroom presentations on topics like driver's education, street law, government, and health. SROs also oversee the 44 law enforcement-conducted lockdown drills at all village schools.

Plainfield Police D.A.R.E. Officers are responsible for elementary schools in the village, conducting 37 D.A.R.E. classes weekly across nine elementary schools, with a total of 790 students participating in the program.

The Juvenile Investigations Unit is overseen by Sergeant Mulacek who fills in at schools when an SRO or Juvenile Detective is unavailable. Additionally, Sergeant Mulacek serves on the Plainfield and Oswego School District Safety and Threat Assessment Committees, as well as the Will County Regional Office of Education Safety Task Force.











Neighborhood Scoops remained focused on larger parks that serve multiple neighborhoods. The police department scooped 75 gallons of ice cream over the summer. In 2023, the police department collaborated with the Plainfield Library, combining two Scoops events with **Plainfield Library** Story Walks.



In 2023, the Plainfield Police Department partnered with McDonald's and Culver's to host Lunch with the Law events, held twice a month at different locations from 11:00 AM to 1:00 PM. Officers arranged tables to interact with community members during their lunch and snack breaks. Additionally, these gatherings doubled as fundraising occasions for the Department's D.A.R.E. program, as the participating restaurants pledged to contribute a portion of their sales during the specified hours to support the D.A.R.E. Program.











#### **National Night Out**

National Night Out was hosted at Settlers' Park, marking a significant village celebration aimed at fostering closer ties between law enforcement and the community on August 1, 2023. This year, the event boasted 36 vendors, contributing to its success. Highlights included music by School of Rock, food generously provided by our local Target, a touch-a-truck event, a Taekwondo demonstration, the Special Olympics MRAP pull, and a meet and greet with the Plainfield Police Department Mascot, Copper. As the night drew to a close, approximately 3,000 people attended to revel in the festivities.













#### **Shop with a Cop**

Our annual Shop with a Cop Event was held on December 21, 2023, at the Plainfield Target, bringing Christmas cheer to 42 less fortunate students from Plainfield School District 202 and Oswego School District 308. Target generously provided wrapping paper and snacks during the event. Detective Allen, known as the Grinch, brought extra smiles to all attendees. Fundraising for this year's event also included the annual 8th grade boys' Shop With a Cop Basketball Tournament, dubbed the Rumble on Ridge, held at Murphy Jr. High School. The 12-team tournament involved every middle school in Plainfield and Oswego School Districts. The Thompson Tigers from Thompson Jr. High School in Oswego emerged as winners, claiming the traveling shopping cart trophy, and approximately \$9,000 was raised for Shop With A Cop.















### **Patrol Division**

The Plainfield Police Department's Patrol Division is the backbone of law enforcement in the community, responsible for maintaining public safety, responding to emergencies, and enforcing laws. The division operates with four shifts, ensuring continuous coverage to meet the community's needs. Additionally, specialized units within the division include Community Service Officers, who facilitate non-emergency calls and engage in community outreach; the Traffic Unit, dedicated to enforcing traffic laws and investigating accidents; Crossing Guards, ensuring pedestrian safety, especially for school children; and volunteer Chaplains, providing emotional and spiritual support during crises.

Each shift and specialized unit operate under the supervision of experienced Sergeants, ensuring the efficient coordination of resources and adherence to departmental policies. Together, these units and shifts work tirelessly to uphold the safety and security of Plainfield's residents.

#### DAY SHIFT A & B

Day Shifts A/B officers handle various tasks, including responding to calls for service, conducting proactive patrols in residential and commercial areas, enforcing traffic laws, and assisting with special events or emergencies as needed.

#### COMMUNITY SERVICE OFFICERS

Serve as a bridge between law enforcement and the community, assisting with non-emergency calls, traffic control, and school crossings. Their presence helps to strengthen relationships with residents, address quality-of-life concerns, and promote a sense of trust and cooperation within the community.

#### CROSSING GUARDS

Responsible for ensuring the safe passage of pedestrians, particularly school children, at designated crossings. Their presence helps to safeguard vulnerable road users and minimize the risk of accidents, especially during peak school commuting hours.

#### **NIGHT SHIFT A & B**

Night Shifts A/B officers primarily work during nighttime hours, handling a wide range of tasks such as responding to emergencies, monitoring suspicious activities, enforcing curfew laws, and ensuring the safety of businesses and residents during the night.

#### TRAFFIC UNIT

Dedicated to promoting road safety by enforcing traffic laws, investigating accidents, and implementing measures to reduce traffic congestion. With a focus on ensuring the smooth flow of traffic and minimizing roadway hazards, traffic officers play a vital role in enhancing public safety on Plainfield's streets.


#### CHAPLAINS








## **Patrol Division**

### **Patrol Division**

In 2023, the Patrol Division provided specialized training to a range of officers, designating them as additional Officers in Charge (OIC) to enhance leadership skills within the team. This initiative underscores the department's commitment to excellence and developing future leaders through internal training. While the Patrol Division aims to always have a Sergeant on duty, manpower limitations currently prevent this. When a Sergeant is not on duty, the OIC supervises the shift. Taught by Sergeants and members of the Command Staff, the OIC training course was a crucial step in ensuring our OICs are properly trained to execute the mission of the Police Department.

Officers in Charge (OIC) play a pivotal role within the police department, acting as the linchpin between the rank-and-file officers and higher command. They are responsible for overseeing daily operations, making critical decisions in the field, and ensuring that all protocols and procedures are meticulously followed. OICs also mentor junior officers, providing guidance and support to cultivate the next generation of law enforcement leaders.

The comprehensive training program for new OICs is designed to enhance their leadership capabilities, focusing on strategic decision-making, effective communication, and crisis management. By equipping these officers with advanced skills, the Plainfield Police Department aims to elevate the standards of safety, service, and professionalism within the Patrol Division.

This training initiative is a testament to the department's proactive approach to law enforcement, emphasizing continuous improvement and professional development. The new OICs will be instrumental in driving positive change, ensuring that the community receives the highest level of service and protection.





## **Patrol Division**

In August 2023, the Plainfield Police Department launched its annual Back-to-School initiative, where all sworn officers warmly welcomed parents and students back to school. Standing at school entrances, Officers provided encouragement and support, fostering a positive and safe environment for the new academic year. This initiative embodies the department's commitment to community policing, building trust, and promoting positive interactions within the community, ensuring students feel supported and empowered as they return to school.

The Patrol Division covers a wide array of essential services to ensure community safety and well-being, including responding to crimes in progress, quality of life issues, emergency and non-emergency calls, crashes, and alarm calls. They conduct vacation house checks, complete mental health reports for the State of Illinois, address parking issues and issue tickets, enforce DUI laws, provide extra patrols, and visit block parties. When not responding to calls, Officers patrol school zones, monitor high-traffic complaint areas, patrol neighborhoods, and engage with the community. This comprehensive approach maintains a vigilant presence, enhances community relations, and upholds the highest standards of public safety and service. Below are some examples of services performed by Officers in 2023:





### **Patrol Division**

#### **Officer Wellness**

The Plainfield Police Department's Patrol Division has implemented a robust Officer Wellness Initiative aimed at promoting both physical and mental well-being among its officers. As part of this initiative, officers are encouraged to prioritize regular workouts and engage in physical activities to maintain their fitness levels and manage stress effectively. Additionally, officers are provided with opportunities to meet regularly with mental health professionals to address any emotional or psychological challenges they may encounter on the job. By prioritizing both physical fitness and mental health, the department aims to support its officers in maintaining overall well-being, resilience, and readiness to serve the community effectively.





#### **Body Worn Cameras**

In August 2023, the Plainfield Police
Department took a significant step
forward in enhancing transparency and
accountability by implementing bodyworn cameras. This pivotal technology is
now utilized by the Patrol Division on the
streets, providing an additional layer of
oversight and documentation to law
enforcement interactions. With bodyworn cameras in place, officers can
ensure the integrity of their actions while
fostering greater trust and confidence
within the community they serve.



## **Traffic Unit**

The Traffic Unit plays a crucial role in ensuring road safety by enforcing traffic laws, investigating accidents, and managing traffic flow. Officers in this unit undergo specialized training in accident reconstruction, DUI enforcement, and traffic control techniques. They work to prevent accidents, reduce congestion, and educate the public on safe driving practices through enforcement initiatives and community outreach programs.

### Fleet Maintenance

Patrol Operations serve as the foundation of our department, safeguarding community safety day in and day out. Yet, without Melanie Silunas's meticulous oversight as our Fleet Maintenance Coordinator, the effectiveness of our fleet would be in jeopardy. Melanie's diligent work ensures that our vehicles remain in prime condition, ready for swift deployment whenever the need arises.

In her role, Melanie is entrusted with managing all aspects of vehicle maintenance within the department. From routine upkeep to coordinating the integration of new vehicles, her attention to detail is unparalleled. Additionally, Melanie orchestrates the careful removal of equipment from retired vehicles, allowing us to repurpose serviceable items and realize cost savings. Thanks to Melanie's dedication, our department operates with enhanced efficiency and readiness, bolstering our ability to serve the community effectively.





### **Community Service Officers**

Community Service Officers (CSOs) with the Plainfield Police Department fulfill a diverse array of vital roles, including handling animal calls, managing school crossings, providing fingerprinting services, controlling traffic, conducting neighborhood checks, and more. They serve as liaisons between law enforcement and the community, offering assistance and support in various situations. Whether ensuring the safety of schoolchildren, assisting with lost pets, or enhancing neighborhood security, CSOs exemplify dedication to public service and contribute significantly to fostering a safe and harmonious community environment.



## **Crossing Guards**

Department are integral to community
safety, particularly in busy intersections and
school zones. Dedicated to safeguarding
pedestrians, especially children, they ensure
smooth traffic flow while emphasizing
adherence to safety protocols. Through their
vigilant presence and guidance, they
contribute significantly to creating a secure
environment for residents. Their
commitment to public safety exemplifies the
department's mission to protect and serve
the community with diligence and care.



# **Explorer Program**

The Plainfield Police Department Explorer Program offers adolescents aged fourteen to twenty an opportunity to explore a career in law enforcement. Participants receive bi-weekly training sessions covering various aspects of policing, including teamwork, handcuffing, traffic procedures, weapons safety, and more. Beyond career insights, the program fosters leadership, public speaking, and confidence skills. Led by Senior Advisor Sergeant Colin Mulacek and Associate Advisor Officer Abigail Olson, the Explorer Post seeks to replenish its ranks after losing members to college. Despite challenges, the Explorers remain active in community events like Neighborhood Scoops, National Night Out, and Cruise Night, and also took part in the MRAP Pull.










# **Chaplain Program**



First certified as an accredited agency in 2010, the Plainfield Police Department utilizes the Commission on Accreditation for Law Enforcement Agencies (CALEA) to develop and maintain the best policies and procedures related to policy development, content, and training.





# **Special Events**

One of the best ways to enhance the relationship between the community and the Plainfield Police Department is through special events. In 2023, the Village of Plainfield remained committed in providing the community with the ability to interact with officers throughout the year during these events.

### **Paddy Day Mile Run**

#### **Plainfield Irish Parade**

A longstanding tradition of the Village of Plainfield, this parade, organized by the Village Preservation Association, celebrated its 19th year. The parade begins and ends at Plainfield Central High School, traveling in and around the downtown area.

This parade, organized by the Plainfield American Legion Post, honors those who paid the ultimate sacrifice for our country. The parade begins at Ira Jones Middle School and concludes at Settlers' Park, where a ceremony wraps up the event.





## **Special Events**




### **Records Unit**

At the core of every issued ticket, warning, crash report, police report, and criminal investigation lies the indispensable contribution of the records unit. Tasked with inputting, reporting, storing, maintaining, releasing, expunging, and disposing of documents, this unit holds a pivotal position within the Police Department.

Comprising solely civilian personnel, the Records Unit consists of one supervisor, three full-time employees, and one part-time employee. Together, they not only fulfill these essential duties but also serve as the initial point of contact for all walk-in or called-in interactions with the police department.

In 2023, the total payments processed by the records unit front desk amounted to approximately \$186,244.







## Plainfield Emergency Management Agency

The Plainfield Emergency Management Agency (PEMA) is a volunteer-driven organization operating under the auspices of the police department. Its primary objective is to strategize for, react to, and aid in the recuperation from significant emergencies or calamities that could affect the residents and infrastructure of the Village of Plainfield.



Structured within the Police Department, PEMA relies on the commitment of volunteers. In 2023 alone, these dedicated individuals collectively contributed over 3,878 hours of service to the Village of Plainfield, showcasing their unwavering dedication to community safety and well-being.
